Scholarships

Our scholarship program launched in 2016 and we are gearing up for our third year of the program. Scholarships are open to graduating seniors at MVRHS and applicants must be pursuing post-secondary programs including technical/trade/certificate programs, associates degrees, and 4+ year degrees. Our first year we awarded \$6,500 to the Class of 2016, \$14,500 to the Class of 2017, and \$16,000 to the Class of 2018! More information can be found at <http://friendsofmascoma.org/scholarship/>. Mini-Grants

Mini-grants are modest awards that help educators make a positive difference in the learning experience of their students. Mini-grants support, encourage, and facilitate great teaching ideas that would not be possible within the existing school budget. Any member of the MVRSD's instructional or professional staff (i.e., teachers, counselors, librarians, paraprofessionals, or nurses) is eligible to apply for a mini-grant. Grants are awarded based on the quality of the idea and the projected impact of the project presented in the application. As of June 2018 we have awarded over \$15,500 in mini-grants! This program provides food to district residents via two food pantries, which are located in Enfield and Canaan. We are working to expand this program by supporting school and community gardens in the district.
