Pt III, Line 31: Primary Exempt Purpose: The object for which this Organization is created is to establish and maintain a philanthropic organization to benefit the Mascoma Valley Regional School District (hereinafter the District). The purpose of the Friends of Mascoma Foundation (hereinafter the Foundation) is to provide support to the Mascoma Valley Regional School District on short-term and long-term initiatives that foster educational development and nutritional well-being for our students and their families. The targeted beneficiaries of the Foundation are the school facilities, faculty, students, and their families within the District.

Pt III, Line 31: Accomplishments 2018: Our food insecurity program called Friends Feeding Friends brought in over 138,000 pounds of food to offer to residents of the Mascoma Valley through our two public pantries and an in-house school pantry that is a resource for all of our school buildings. We had 1,934 household visits during the year and offered 355 boxes of food and personal items to school families throughout the year during school breaks. We have over 400 registered household clients. We have a mini-grant program to promote and encourage our Mascoma Valley Regional School District staff to facilitate great teaching ideas or creative enrichment projects that benefit our students. We awarded over \$8,000 to some projects such as a place-based Ecology Education Outdoor Classroom, keyboards for chorus, creating side tables with a local craftsman in woodworking shop, a problem solving program, a HOB0 data Logging program, a projectile motion project, a NYC fashion trip for a textile class, and a farm to school garden project. FOM awarded a record number of scholarships in 2018, by giving 15 scholarships to 14 students that totaled \$16,000. We award MVRSD seniors who are furthering their education by attending four year, trade, technical, or certificate

schools. Some special projects were a Warm Clothing Giveaway for our Mascoma Families that benefitted over 100 households. Furthermore, we completed an art initiative project that sponsored an artist-in-residence program that created a large tapestry called Seasons of Growth that graces our MVRHS media center and library for generations to admire.
