Pt III, Line 2: Primary Exempt Purpose: The object for which this Organization is created is to establish and maintain a philanthropic organization to benefit the Mascoma Valley Regional School District (hereinafter the District). The purpose of the Friends of Mascoma Foundation (hereinafter the Foundation) is to provide support to the Mascoma Valley Regional School District on short-term and long-term initiatives that foster educational development and nutritional well-being for our students and their families. The targeted beneficiaries of the Foundation are the school facilities, faculty, students, and their families within the District.

Pt III, Line 3: Accomplishments 2020: Our food insecurity program called Friends Feeding Friends brought in 92,500 pounds of food to offer to residents of the Mascoma Valley through our two public pantries and an in-school pantry that is a resource for all of the four school buildings in the District. There were 2,100 household visits at the two public pantries. We also supplied 300 boxes of food and personal items to school families during Holiday and school breaks.

We have over 500 households that have registered with us. Our mini-grant program promotes and encourages our Mascoma Valley Regional School District staff to facilitate great teaching ideas or creative enrichment projects that benefit our students. We awarded \$3,520 to projects such as warm socks for use with outdoor cold-weather activities, umbrellas for outdoor rainy-day activities, backpacks for our school pantry weekend take-home food packs, headphones for remote learning, and funding for an inclusive elementary playground.

FOM awarded 15 scholarships to recent graduating seniors as well as past recipients that totaled \$16,380. We award scholarships to graduating
